#### **Personal Behaviour**

10 Use of Association's property, income, assets and records including members details and databases and mailing lists, shall solely be applied towards the promotion and furtherance of the Association and not for private use or benefits.

#### **Potential conflicts of interest**

11 Potential conflict of interests should be disclosed and noted in meeting minutes prior to committee deliberation on the potential conflict of interest. Furthermore, members with the potential conflict of interest should be abstaining from voting on the matter.

### **Gifts and gratuities**

- 12 Gifts and gratuities received by Directors that may impact their independence and objectivity in Board decision making should disclose these in writing in a gift register.
- 13 Immediately report any breaches of the Kiteboarding Western Australia Inc Codes of Conduct to the appropriate authority (i.e. to the President or Vice President).
